# **Dutch Challenger Open**

which will be held at Thialf Heerenveen, the Netherlands January 24 -25, 2026

## **General Regulations**

The competitions will be held under the 2024 ISU General Regulations and Special Regulations and the relevant communications.

Participation is open to all ISU Members. This competition is part of the Challenger Series Short Track 2025-2026. The competition will be a knock-out system.

#### **Distances**

Individual 500, 1000, meters Women and Men

Relay 2000 meters Mixed Team Relay, 3000 meters Women and 5000m Men

Based on the ISU Communication 2532, the Dutch Challenger Open Short Track Competition will use the 'zero false starts' rule.

## **Program**

#### **Track Conditions**

The Elfstedenhal has an artificially refrigerated indoor ice surface of 60 x 30 meters. Protective padding covers the boards in accordance with Rule 280, paragraph 5 and ISU Communication No. 2365 (or any further update). The standard track will be laid out 111.12 meters to the lap.

#### **Entries**

- This competition is for the following Categories: Senior, Junior A & B
- Only registered competitors of ISU Members and affiliated clubs are allowed to participate;
  entries can be made only through the respective members.
- Only those competitors who have submitted their entries and paid the entry fee by the given deadline are allowed to participate.

Please indicate your intention of participation as soon as possible to enable us to prepare the competition as well as possible. Participation will be based on a first come first serve policy.

Due to the limited ice time, we have a maximum entry: 75 men and 55 women that can take part in the competition.

Final Entries must reach the Organizing Committee on **January Friday 9, 2026** and the following information must be communicated to the Organizing Committee:

- Names of the Competitors and a list of alternate names per category with their International Registration Numbers.
- Names of the Competitors and their personal best time, recorded during the period of eligibility, for all individual distances they might participate in.
- Names of the Competitors for each of the respective individual distances.
- Confirmation of participation in all the competitions of the Relay.

Only the Competitors listed on the Final Entry, respecting the maximum number of entries allowed, can attend and receive an accreditation for the Event.

#### Citizenships/Residence Requirements and Clearance Procedure

In accordance with Rule 109 of the ISU Regulations and ISU Communication No. 2526, all Skaters who do not have the nationality of the ISU Member by which they have been entered or who, although having such nationality, have in the past represented another ISU Member, must produce an ISU Clearance Certificate.

## **Entry Fee**

An entry Fee of €75,00 must be paid per skater.

## **Entry**

The entry for this competition will start on **December 22, 2025, and close on January 9, 2026.** Entries must be made by the Club Competition Secretary or Federations by using your standard login password on the Entry page of the website:

If a login password is not available, it can be applied for using the special form on the Entry-page of shorttrackonline.info. Federations cannot use their password for ISU Championships for the competition. You need a separate password for this competition.

### **Payment Entry Fee**

After the Entry for the competition has closed, an invoice will be sent to the email address which is registered in the Entry system.

The invoice will contain a BOOKING NUMBER, the amount to be paid and the information on the bank account to transfer the payment to. We request that you use the booking number as the reference and make the payment immediately after receiving the invoice.

#### **Helmet covers:**

For the helmet covers, a deposit must be paid of €10.00 per helmet cover with a maximum of €50,00 per club/team. The deposit must be paid in cash upon arrival at the registration desk and will be refunded after the competition when returning the helmet covers.

## **Anti-Doping**

Anti-Doping tests may be carried out according to the ISU Anti-Doping Rules and ISU Anti-Doping Procedures, as given in the applicable ISU Communications (ISU Communications Nos. 2344 & 2366 or later updates).

#### Medics

A fully equipped medical team will be present during competition hours.

## Liability

In accordance with Rule 119 of the ISU General Regulations, the ISU, Koninklijke Nederlandsche Schaatsenrijders Bond and The Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the ISU Junior World Cup Short Track Speed Skating Competition. Each Member is solely responsible for providing insurance coverage thereto.
