Competition Agreements and Agreements

This competition is being organised in accordance with the Agreements and Regulations BeNeLux-Cup 2025-2026 published on ShorttrackOnline.

Provisional Program:

Skater registration: 07.15h – 08.00h (should a club **only** have riders from categories

ABCSM, please contact the organising committee for registration)

Warming-up: 08.00h

Start of competition: 08.30h End of competition: 15.00h

Notice: The final program will be published on www.ShorttrackOnline.info a few days before the start of the competition. Be sure to check this in advance.

Distances:

The distances will be determined based on the number of skaters and the available time.

To ensure skaters ranked in a lower division have the possibility to qualify for a higher division in the next competition, the organizing committee & Competitor Steward will strive to schedule a full set of distances which are used for division ranking (500 / 1.000 / 1.500 m). If this is not possible, for example due to time schedule, a minimum of 1 race in one of the beforementioned distances is scheduled for those skaters.

Entry:

Through the relevant club's competition secretary via www.shorttrackonline.info. Closing entry: FridayNovember 7th 2025.







Participation in the BeNeLux-Cup:

All skaters registered by a club in Belgium, the Dutch region "Gewest Noord-Brabant / Limburg / Zeeland" or Luxembourg are allowed to participate in the BeNeLux-Cup. Participating skaters must have a valid competition license from their own federation in order to compete in the BeNeLux-Cup.

Participation of skaters from outside the region

- 1. Participation of skaters from Dutch regions is only possible if skaters are not allowed to participate in their own region, due to their regulations. This will only be possible for skaters in age category Jun ABC or Senior/Master.
- 2. Participation of skaters from other countries is possible for skaters in age category Jun ABC or Senior/Master.

These skaters should be entered by their club secretariat on the waiting list on https://shorttrackonline.info/entry.php

Registration for participating for skaters from outside the region

Skaters can be registered by their club secretariat on the waiting list. After closing of the entry, the organizing committee and Competitor Steward will decide how many and which skaters will be let in to the competition. Organizing committee will inform the club secretariat of the skaters at the latest Monday prior to the competition. If more places become available later in the week, other skaters from the waiting list can be contacted (via their club secretariat) to join the competition.

Division:

In the program / composition of divisions, the organising committee will take into account the latest developments regarding the Starclass limits, as well as the participation of skaters with less experience. The organisers reserve the right to change the composition of the divisions in the interest of safety and / or a good competition.

Start procedure:

For all categories there will be a tolerance of one false start.

Category:

Junior F: born after 30/06/2016

Junior E: born from 1/07/2014 to 30/06/2016 Junior D: born from 1/07/2012 to 30/06/2014 Junior C: born from 1/07/2010 to 30/06/2012 Junior B: born from 1/07/2008 to 30/06/2010







Junior A: born from 1/07/2006 to 30/06/2008 Senior & Masters: born before 30/06/2006

Awards:

EF: all participants will be awarded with a medal. Individual classification DEF & ABCS: awards will be given to the first, second and third in the final classification of each category.

Helmet caps:

All skaters need to have helmet caps. A deposit of € 50,- per club will be charged. We kindly ask you to bring the exact amount in cash in an envelope with the club name and the amount on it. The caps will be handed out before the competition. After the competition the caps need to be returned and the deposit can be retrieved. If the rider needs stickers instead of a cap because of the use of a skate-Tec 025 Visor they must indicate this immediately upon registration. These stickers will cost €2,-.

Registration fee:

An entry fee of € 35,00 must be paid to the organisers for every athlete. To reduce the amount of cash and fast handling, we ask you to wire the money by bank transfer to organiser bank account no later then Wednesday November 12th 2025.

This number should correspond to the number of entered skaters on ShorttrackOnline). For example: Benelux NSV 5 with code 8060. Clubs can only make entries with the approval of their respective ISU Member at: shorttrackonline.info







Track Conditions:

The track is an artificially refrigerated indoor ice surface with the measures of 30 x 60 meters. The protective padding is in accordance with ISU Communication No. 2365. The standard track will be laid out 111.12 meters to the lap with measured curves of 8 meters and there will be 7 markers used to establish the curve. The length of the straight is 28.85 meters. Beside the original track there will be 4 tracks set up to preserve good ice conditions. For all tracks one finish line will be used.

Safety:

The KNSB have issued Safety Regulations applicable to all competitions in The Netherlands (https://knsb.nl/documents/64/2ccb8a99-shorttrack-communique-2b-baanbeveiliging-st-2023-2024_v25072023.pdf). These regulations will be applicable to all participating skaters in Category C and above. Skaters in Category D-E-F and "Kids on ice" should comply with ISU Communication 1265 (helmet, shin and knee protection, cut-free gloves and neck protection) and applicable Rules such as Rule 291. For more information see: ISU Communication (www.isu.org).

<u>Medical Insurance</u>: It is the sole responsibility of each member, on behalf of its participating clubs, to ensure or provide medical and accident insurance for their athletes. Proof of such can be requested by the Organizing Committee. See ISU Rule 119.

Medical Assistance:

Emergency first aid personnel will be present at the competition. There will be an adequate response time for an ambulance to be on site in case of need.

<u>Liability</u>: In accordance with Rule 119 of the ISU General Regulations, the ISU, the KNSB and the Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the competition. Each Member is solely responsible for providing insurance (medical and accident) coverage for their athletes.

<u>Parking</u>: Parking is available around the Triavium Ice Rink. Day tickets ($\le 5, -$) are available at the reception of Triavium, or payment by bank contact at the exit ($\le 9, -$) per day.
